Judicial Performance Evaluation Reports

Fauquier County Judges Rank at Bottom of Official Judicial Evaluations!

Virginia Code § 17.1-100 requires that "By December 1 of each year, the Supreme Court, or its designee, shall transmit a report of the evaluation in the final year of the term of each justice and judge whose term expires during the next session of the General Assembly to the Chairmen of the House and Senate Committees for Courts of Justice."

On December 1, 2016, the Executive Secretary of the Virginia Supreme Court submitted evaluation reports for 27 judges eligible for reelection during the 2017 session of the General Assembly. Three judges from the 20th Circuit in Fauquier County are eligible for reelection and received evaluations, namely Judge Jeffrey W. Parker of the Circuit Court, Judge J. Gregory Ashwell of the District Court, and Judge Pamela L. Brooks of the Juvenile and Domestic Relations District Court. These judges received poor ratings compared to other judges eligible for reappointment. As shown in the attached, each of these judges ranked <u>LAST</u> in performance compared to their peers being considered for reappointment.

Fauquier County deserves better judges than this!

2016 Ratings for Judge Jeffrey W. Parker

Judge Jeffrey Parker ranks **LAST** in overall performance among circuit court judges currently being considered for reappointment by the General Assembly.

Among the 25 circuit court judges who have been officially evaluated for reappointment in the past three years, Judge Parker ranks 23rd.

155 attorneys and jurors submitted reviews of Judge Parker. Of these, only 56 percent found that he displays knowledge of the law every time, only 58 percent found that he is faithful to the law every time, only 54 percent found that he allows lawyers appropriate latitude in presenting their case every time, and only 58 percent found that he exhibits fairness to all parties every time. Only 55.6 percent rated Judge Parker's overall performance as "excellent."
